#### Notes

### Codes A through to C inclusive are PAF matches, this equates to 51,217 records which is 45% of the data supplied.

Codes D through to F inclusive are those that have significant elements of the address, however could not be found on the PAF file. This accounts for 18,887 records (17%)

Codes G onwards are generally not recommended to be mailed. This is due to significant key elements of the address not being able to be identified within the data supplied.

Before processing the number of mailable records were 47,487 which is 42% and after processing it becomes 70,104 which is 62% that is a a change of 22,617 records
